

**BOARD OF ADA COUNTY COMMISSIONERS
MINUTES OF THE GENERAL SESSION OF THE INDIGENT HEARING
WEDNESDAY, JANUARY 30, 2013
9:00 A.M.**

The Board of Ada County Commissioners (Board) met this date in Open Session in the Commissioners' Conference Room of the Ada County Courthouse Complex to act on the following items. Staff members present: Bonnie Malmstrom, Toni Hellman, Kelly Helland, John Traylor, and Renee Jaques, Indigent Services; and Jana Gomez, Prosecuting Attorney's Office. Minutes Recorder: Judy Morris.

I. IN THE MATTER OF CALL TO ORDER:

Commissioner David L. Case called the meeting of the Ada County Commissioners to order at 9:00 a.m.

II. IN THE MATTER OF ROLL CALL:

Commissioners David L. Case, Jim Tibbs and Rick Yzaguirre were present.

R. Jaques presented the Staff report for Case No. 1208-130, a request for a partial release of lien. She requested Case No. 0701-007 be withdrawn as she did not receive the information necessary for the presentation. She then presented the joint Staff report for Case Nos. 1011-071 and 1101-052 a request from the Prosecuting Attorney's office to turn the existing Orders of Reimbursement into a Civil Judgment in order to collect funds received from a felony case.
