

**ADA COUNTY BOARD OF COUNTY COMMISSIONERS
MINUTES OF THE MEETING TO SET TAX LEVIES
MONDAY, SEPTEMBER 9, 2012
9:00 A.M.**

The Board of Ada County Commissioners (Board) met this date in the Commissioners’ Conference Room of the Ada County Courthouse Complex to act on the following items. Staff members present: Brad Vanderpool, Chris Rich and Phil McGrane, Clerk’s Office. Minutes Recorder: Judy Morris.

I. IN THE MATTER OF CALL TO ORDER:

Commissioner David L. Case called the meeting of the Ada County Commissioners to order at 9:04 a.m.

II. IN THE MATTER OF ROLL CALL:

Commissioners David L. Case, Jim Tibbs and Rick Yzaguirre were present.

III. IN THE MATTER OF NEW BUSINESS:

- Certification of Tax Levies

C. Rich stated that the Board adopting the proposed tax levies for all of the taxing districts housed within Ada County was required by statute and concluded the budget process.

B. Vanderpool explained that he has not received Melba Cemetery District’s Form L2. He stated he has been unable to reach his contact at Melba Cemetery. P. McGrane advised the Board that if Melba Cemetery submitted anything at this time, it would be at the Board’s discretion how to process it based on when it was received. He discussed the process for setting the 2013 levies. He provided a four year look-back and explained that house values have gone up causing the 2013 levies to go down. He advised that five out of eight fire districts are taking the maximum three percent levy rate.

C. Rich stated that the State Tax Commission will be implementing a new rule in 2014 requiring that the budgets published by districts must match the Form L2s they submit to the State. He said that rule may affect this process in the future.
