

**BOARD OF ADA COUNTY COMMISSIONERS  
MINUTES OF THE GENERAL SESSION OF THE INDIGENT HEARING  
WEDNESDAY, OCTOBER 22, 2014

Commissioner David L. Case called the meeting of the Ada County Commissioners to order at 2:01 p.m.
