

**BOARD OF ADA COUNTY COMMISSIONERS
MINUTES OF THE GENERAL SESSION OF THE INDIGENT HEARING
WEDNESDAY, SEPTEMBER 7, 2016

A. Morales presented the Staff report for Case No. 1604-049, a request to amend the Order of Reimbursement.


The parties discussed Applicant’s bankruptcy status.
