

**BOARD OF ADA COUNTY COMMISSIONERS
MINUTES OF THE GENERAL SESSION OF THE INDIGENT HEARING
FRIDAY, SEPTEMBER 30, 2016
9:00 A.M.**

The Board of Ada County Commissioners (Board) met this date in Open Session in the Commissioners' Conference Room of the Ada County Courthouse Complex to act on the following items. Commissioner Jim Tibbs called the meeting of the Ada County Commissioners to order at 9:01 a.m.


A. Morales presented the Staff report for Case No. 56913, a request to suspend the Application.


VII. IN THE MATTER OF RECESS:
