2. Transfer of such license for the sale of beer shall not authorize transferee to retail beer except by application to the County Commissioners' approval and their amendment of said license to the transferee.
3. Application is to be accompanied by requisite fees and petitions where applicable.
4. Application for and issuance of a Beer License is applicant's consent to allow the Sheriff of Ada County or his/her deputies, the Ada County Commissioners, and the Prosecuting Attorney of Ada County or his/her deputies, to make inspections to determine compliance with ordinances and state laws regulating sale of beer.
5. Copy of State of Idaho license must be attached hereto.
