

A RESOLUTION GIVING NOTICE OF THE FILING OF A PETITION REQUESTING THE FORMATION OF A COMMUNITY INFRASTRUCTURE DISTRICT IN THE NORTHERN PORTION OF ADA COUNTY, INCLUDING PORTIONS OF THE AVIMOR PLANNED COMMUNITY; ORDERING THE SCHEDULING OF A PUBLIC HEARING ON FEBRUARY 25, 2015, AT 6:00 P.M., TO CONSIDER THE PETITION; DIRECTING THE DIRECTOR OF DEVELOPMENT SERVICES TO COMPLY WITH THE NOTICE PROVISIONS OF I.C. § 50-3103(2) TO PUBLISH AND SEND DIRECT NOTICE TO THE RESIDENTS AND OWNERS OF THE PROPERTY IN THE PROPOSED DISTRICT; AND TO PROVIDE AN EFFECTIVE DATE.

WHEREAS, a petition requesting the formation of the Avimor Community Infrastructure District No.1 was filed with the Clerk of the Board of Ada County Commissioners on January 23, 2015;

WHEREAS, Idaho Code § 50-3103(2) requires the Board of Ada County Commissioners to order a public hearing by resolution and that such public hearing to consider the Petition must be held at a regular or special meeting of the Board of County Commissioners between thirty and ninety days after the filing of such a petition;

WHEREAS, the regular meeting of the Board of Ada County Commissioners on February 25, 2015, at 6:00 p.m. meets these statutory requirements;

WHEREAS, Idaho Code § 50-3103(2) requires the Board of Ada County Commissioners to mail notices to residents and owners of property in the proposed district as well as to publish notice of the date and place of the public hearing; and

WHEREAS, the same statutory provision requires that the notice also contain language notifying other political subdivisions of the state that have jurisdiction in the proposed district that they may appear and give testimony at the February 25, 2015, public hearing.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF ADA COUNTY COMMISSIONERS that notice of the fact that a Petition requesting the formation of the Avimor

Community Infrastructure District No. 1 has been filed with the Clerk of the Board of Ada County Commissioners and that a public hearing for the consideration of the Petition is hereby ordered for the regular meeting of the Board of Ada County Commissioners on February 25, 2015, at 6:00 p.m. in the Public Hearing Room of the Ada County Courthouse.

BE IT FURTHER RESOLVED that the Director of Development Services is hereby directed to comply with the Idaho Code § 50-3103(2) notice requirements and cause to be mailed such notices as are thereby required and to publish in a newspaper of general circulation as described in the Idaho Code, proper notice as provided therein.

BE IT FURTHER RESOLVED that this Resolution shall be in full force and effect immediately upon its adoption and approval.
