

RESOLUTION CREATING A SHORT LIST FOR THE RETENTION OF PROFESSIONAL LANDSCAPE ARCHITECTURE FIRMS FOR PROJECTS IN WHICH THE PROFESSIONAL SERVICE FEE WILL NOT EXCEED \$25,000.

At a meeting of the Board of County Commissioners, County of Ada, State of Idaho on this 22nd day of March, 2016, the following resolution was adopted as follows, to wit:

WHEREAS, the Board of Commissioners desires to secure contracts for the services of professional landscape architecture firms for projects in which the professional service fee will not exceed \$25,000; and

WHEREAS, pursuant to Idaho Code Section 67-2320(3), the Board of Commissioners established its own guidelines in Resolution No. 2098 for selection of landscape architecture firms for projects where the professional service fee will not exceed \$25,000 based upon demonstrated competence and qualifications to perform the type of services required; and

WHEREAS, Resolution No. 2098 requires that Ada County Procurement issue a Request for Qualifications (“RFQ”) to select professional landscape architecture firms to create a short list (“List”) from which to choose landscape architecture firms for specific small County projects for fees less than \$25,000; and

WHEREAS, Resolution No. 2098 allows the Board of County Commissioners to select three to five qualified landscape architecture firms which will comprise the List; and

WHEREAS, per Resolution No. 2098, firms on the List shall be eligible for consideration for County projects for fees less than \$25,000; and

WHEREAS, the Board of Commissioners issued RFQ No. 16030 in order to create a List as set forth above; and

WHEREAS, through RFQ No. 16030, the Board of Commissioners has selected three to five qualified landscape architecture firms to comprise the List;

NOW, THEREFORE, BE IT RESOLVED that the Board of Ada County Commissioners does hereby adopt the following List from which to retain professional landscape architecture firms for projects in which the professional service fee will not exceed \$25,000.

A. Landscape Architecture List:

1. Breckon Land Design
2. CTA Inc.
3. KM Engineering
