

## **SUMMARY OF ADA COUNTY ORDINANCE NO. 854**

AN ORDINANCE AMENDING ADA COUNTY CODE TITLE 2 AS FOLLOWS: AMENDING THE ADA COUNTY CODE TITLE 2 TO ADD A NEW CHAPTER 6 ENTITLED EXPO IDAHO FACILITIES; TO PROVIDE FOR THE PURPOSE OF THE CHAPTER; TO PROVIDE FOR DEFINITIONS; TO PROVIDE FOR THE ESTABLISHMENT AND PURPOSE OF THE EXPO IDAHO ADVISORY BOARD; TO PROVIDE FOR THE CONTINUATION OF THE EXPO IDAHO ADVISORY BOARD EXISTING MEMBERSHIP AND TERMS; TO PROVIDE FOR ENFORCEMENT AND RESPONSIBILITY; TO PROVIDE FOR PET AND LIVESTOCK RESTRICTIONS AND TO MAKE FAILURE TO REMOVE PET FECAL MATTER AN INFRACTION AND PUNISHABLE BY A ONE HUNDRED DOLLAR FINE; TO PROVIDE FOR FIRE, FIREWORKS AND WEAPON/FIREARM RESTRICTIONS; TO PROVIDE FOR THE PRESERVATION OF PROPERTY AND WILDLIFE AND NUISANCE RESTRICTIONS AND TO MAKE VIOLATIONS OF NUISANCE RESTRICTIONS AN INFRACTION PUNISHABLE BY A ONE HUNDRED DOLLAR FINE EXCEPT FOR PUBLIC HEALTH VIOLATIONS WHICH SHALL BE A MISDEMEANOR; TO PROVIDE FOR ADVERTISEMENT, SOLICITATION AND BUSINESS RESTRICTIONS; TO PROVIDE FOR ALCOHOL AND SMOKING RESTRICTIONS; TO PROVIDE FOR PROHIBITED ACTS AND EJECTMENT FROM EXPO IDAHO FOR ENGAGING IN PROHIBITED ACTS; TO PROVIDE FOR PARKING, DRIVING AND CAMPING REGULATIONS AND MAKE A VIOLATION OF SUCH REGULATIONS AN INFRACTION PUNISHABLE BY A ONE HUNDRED DOLLAR FINE; TO PROVIDE THAT VIOLATIONS ARE PUNISHABLE AS A MISDEMEANOR.

ORDINANCE NO. 854 SHALL BE EFFECTIVE UPON PUBLICATION. A FULL TEXT OF THE ORDINANCE IS AVAILABLE FOR PUBLIC INSPECTION AT THE OFFICE OF THE ADA COUNTY CLERK, 200 W. FRONT STREET, BOISE, IDAHO BETWEEN THE HOURS OF 8 AM TO 5 PM MONDAY THROUGH FRIDAY, COUNTY OBSERVED HOLIDAYS EXCEPTED.
