

**RESOLUTION OF THE BOARD OF ADA COUNTY COMMISSIONERS
REPEALING THE 2007 ADA COUNTY COMPREHENSIVE PLAN AND
ADOPTING THE 2025 ADA COUNTY COMPREHENSIVE PLAN**

At a meeting of the Board of Ada County Commissioners, State of Idaho, held on the 9th day of November, 2016, the following Resolution was adopted, to wit:

WHEREAS, on November 27, 2007, the Board of Ada County Commissioners (“Board”) initially adopted the 2007 Ada County Comprehensive Plan (“2007 Plan”) by Resolution No. 1518; and

WHEREAS, the 2007 Plan has been amended periodically to update it with the last amendment made by Resolution No. 2017 on November 17, 2014; and

WHEREAS, the Board finds that current development trends in Ada County necessitate that a new comprehensive plan be adopted to guide growth in Ada County in the future; and

WHEREAS, a petition for the adoption of the 2025 Ada County Comprehensive Plan (“2025 Plan”) was prepared and submitted by Ada County Development Services on July 29, 2016; and

WHEREAS, Development Services staff scheduled the 2025 Plan for public hearing before the Planning and Zoning Commission of Ada County (“Commission”), to be held on September 15, 2016, and on July 29, 2016, notified the six cities and other agencies of this application and solicited their comments; and

WHEREAS, legal notice of the Commission’s hearing was published in *The Idaho Statesman* on August 23, 2016, and a public service announcement was sent to radio and television stations on September 2, 2016; and

WHEREAS, Idaho Code § 67-6509(a) allows the Commission to recommend the plan, amendment to the plan, or repeal of the plan to the governing board; and

WHEREAS, the Commission held a public hearing on the draft 2025 Plan on September 15, 2016, and made a recommendation to adopt the 2025 Plan to the Board; and

WHEREAS, Development Services staff scheduled the 2025 Plan for public hearing before the Board, to be held on November 9, 2016, notified the six cities and other agencies of the proposed 2025 Plan and solicited their comments on September 21, 2016; and

WHEREAS, legal notice of the Board’s November 9, 2016 hearing was published in *The Idaho Statesman* on October 18, 2016, and a public service announcement was sent to radio and television stations on October 21, 2016; and

WHEREAS, Idaho Code § 67-6509(b) provides that the Board may adopt, amend or repeal a Comprehensive Plan.

BE IT THEREFORE RESOLVED by the Board of Ada County Commissioners that:

1. The 2007 Plan is hereby repealed;
2. The 2025 Plan as attached as Exhibit A hereto is adopted for unincorporated Ada County except for those areas of city impact where the applicable city and Ada County have agreed that the applicable city's comprehensive plan governs pursuant to Idaho Code section 67-6526.
