

**Request for Qualification Statements and Bidding Procedure for  
RFB 12010  
Ada County Video Arraignment and Conferencing Purchase and Installation**

The Board of Ada County Commissioners will receive and publicly open sealed and clearly marked qualification statement submittals for Bid 12010, Ada County Video Arraignment and Conferencing Purchase and Installation. The process for this Category B Public Works Bid will be a two-stage process. All interested vendors must first submit Qualification Statements. The County will issue notices to those vendors who meet the qualification standards, who will receive invitations to bid on the project. Only those vendors who receive notice that they are qualified may bid on the project.

**STAGE 1- Qualification Statements**


Sealed qualification statement submittals are to be delivered or mailed to the Ada County Department of Administration, Purchasing Division, 200 W. Front Street, 2<sup>nd</sup> Floor, Room 2210, Boise, Idaho, 83702 no later than 4:00 p.m. MST, on February 13, 2012. All qualification statement submittals will be date and time stamped as they arrive in the Purchasing Division. Information and specifications for same may be obtained at the Ada County Purchasing Division, 200 W. Front Street, 2<sup>nd</sup> Floor, Room 2210, Boise, Idaho 83702 or may be accessed at [www.adaweb.net/bids](http://www.adaweb.net/bids). A plan copy fee of \$25.00 is required for each set picked up in hard copy. Qualification statement submittals will be publicly opened and read aloud on February 14, 2012, on or about 9:00 a.m. MST at the Ada County Courthouse Administration Building, 200 W. Front Street, 3rd Floor, Commissioner's Conference Room, Boise, Idaho. The Board of Ada County Commissioners reserves the right to accept or reject any or all qualification statement submittals.

**STAGE 2- Bidding Procedure**

Sealed bids from only those vendors who pre-qualified in Stage 1 are to be delivered or mailed to the Ada County Department of Administration, Purchasing Division, 200 W. Front St., 2<sup>nd</sup> Floor, Room 2210, Boise, Idaho, 83702 no later than 4:00 p.m. MST, on March 19, 2012. All bids will be date and time stamped as they arrive in the Purchasing Division. Bids will be publicly opened and read aloud on March 20, 2012, on or about 9:00 a.m. at the Ada County Courthouse Administration Building, 200 W. Front St., 3rd Floor, Commissioner's Conference Room, Boise, Idaho. The Board of Ada County Commissioners reserves the right to accept or reject any or all bids.

On February 23, 2012, at 9:00 a.m. MST, there will be a mandatory pre-bid meeting for vendors pre-qualified in Stage 1 at 200 W. Front Street, Boise, ID 83702 in the Ada County Courthouse Operations Department Conference Room.
