### ADA COUNTY WOMEN MAKING HISTORY

Permanent Photo Wall Unveiled at Ada County Courthouse

Ada County Commissioners Ryan Davidson, Rod Beck (Chair) and Kendra Kenyon unveiled a photo wall in the Ada County Courthouse lobby October 17, 2022 honoring trailblazing women leaders. The installation is called "Ada County Women Making History," and features 'firsts' in Ada County.

Those being honored are the late Linda Davis, the first woman Ada County Commissioner (1976), Judge Karen J. Vehlow, the first woman Ada County Magistrate Judge (1977), Judge Deborah A. Bail, the first woman District Judge in the State of Idaho (1983), Jan M. Bennetts, the first woman Prosecutor in Ada County (2014), and Dotti Owens, the first woman Ada County Coroner (2015). Judges Bail, and Vehlow, along with Prosecuting Attorney Jan Bennetts and Ada County Coroner Dotti Owens are still serving in their positions. Friends, family and colleagues were on hand as the five pictures were unveiled. Coincidentally Ada County (Established in 1864) is named after a woman. Ada Riggs, one of the daughters of former Idaho Territorial Legislator H.C. Riggs. We hope the next time you're at the Ada County Courthouse you'll stop by and see the new permanent photo wall exhibit.

The Ada County Animal Control Ordinance is enacted to provide for the health, safety and welfare of the people of Ada County and the humane and safe treatment of various animals. The ordinance also establishes required procedures and regulations for the licensing and control of dogs and kennels.

# WINNER OF THE EXPO IDAHO PARK DESIGN COMPETITION ANNOUNCED

Ada County solicited visions from design professionals for park development at Expo Idaho as required by Idaho Code 67-2320. Three design professionals were selected through the Request for Qualifications process and had the opportunity



to score additional points through an innovative design competition for the park. PORT was given the highest ranking after the scoring

of the design concept piece of the Request for Qualifications. At this point, as required by statute, the County has entered into fee negotiations with Port. If those negotiations are not successful, the County will negotiate with the second highest ranking design professional.


#### ADA COUNTY COMMISSIONERS DESIGNATE OCTOBER AS DOMESTIC VIOLENCE AWARENESS MONTH
