

A vote on the FY24 Ada County budget is scheduled August 15th at 9:00 AM during the Board's Open Business Meeting.

Most homeowners in Ada County will pay approximately 12% less in property taxes for the Ada County portion of their tax bill in the coming fiscal year.

David Hayward Recognized for 30 years of outstanding service to Ada County Weed Pest and Mosquito Abatement

Doing anything for 30 years says a lot about a person. Working somewhere for 30 years says a lot about a place. We are so honored to recognize David Hayward for 30 years of service to Ada County Weed, Pest and Mosquito Abatement. “I believe in loyalty,” Dave says, and he certainly has been a loyal, valuable, and well-liked employee who everyone says is just a great person to be around.



Prior to working for Ada County, David served for 16 years in the National Guard before being honorably discharged. In the winter of 1993, David left his job framing houses to work with his dad on a gopher crew based in Eagle. He was quickly offered a mechanic position with Ada County Weed and Pest Abatement that utilized his background in maintenance from the Military.

David performed maintenance on the vehicles and helped as a Weed Control Applicator. When the Ada County Mosquito Abatement District joined the agency in 2005, David’s role changed to reflect his current position as the Facility/Inventory Specialist, focusing on keeping inventory, ordering products, and handling product dispersal in applicators’ lockers.

David greatly appreciates all the people he has gotten to work with over the years. Though the technology is always changing, he is impressed by his colleagues’ willingness to go out and do the work to minimize problems from noxious weeds, pests, and mosquitoes throughout Ada County. The accomplishment David is most proud of is reaching 30 years of service with Ada County Weed, Pest and Mosquito Abatement because, as he explains, “I believe in loyalty. The people that I have worked with have been loyal to me, and I have tried my best to be loyal in return. The county has been very good to me.”

ACHD HOSTS JOINT MEETING WITH ADA COUNTY

Ada County Commissioners Ryan Davidson, Chairman Rod Beck and Tom Dayley met in Garden City with ACHD's five elected commissioners in July. The joint meeting was an opportunity for the two political entities to collaborate on issues affecting Ada County motorists, pedestrians and cyclists – anyone who uses Ada County roadways. Included in the discussion was an update on Chip Sealing in our area.



Also discussed at the joint meeting - HB237 which the Idaho legislature passed this year that requires highway district property tax funds to be primarily for cars.

Did you know that Ada County, and the [Ada County Highway District \(ACHD\)](#) are two totally separate political entities, with their own elected officials? Ada County is the seat of government in the county. ACHD on the other hand plans, designs, and manages roads throughout Ada County including each of Ada's six sister cities – Star, Eagle, Meridian, Garden City, Boise and Kuna.

ACHD is the only political entity of its kind in the country. While that can be confusing at first to people who have recently moved to our area – ACHD has been in existence since 1972.
