## TAX SCAM TARGETS ADA COUNTY HOMEOWNERS


Residents of Ada County are being targeted by con artists. If you receive a delinquent tax notice that looks like the ones pictured here – throw it away. This is a scam meant to victimize Idahoans.

The letters are from a place called the "Ada County Tax Processing Unit." There is no such place. They look official but they are not.

You'll read that you have unpaid taxes and that a lien is about to be placed on your property. If you call the number provided, the company says they are an intermediary in settlement negotiations. The Idaho Attorney General's Office is aware of this scam and is working with Ada County to warn residents.

### **REVIEW OF OUR RESOURCES: PARKS & WATERWAYS**

Hello there again! My name is Nick Kochergin, and I am the Ada County Communications intern. This month I am reporting on Ada County Parks & Waterways. From bike parks, conservation lands, and recreation areas, Parks & Waterways has a wide range of responsibilities that protect and enhance some of the most valuable amenities Ada County has to offer.

My tour of land managed by Ada County was led by Robert Sosin, the program & education specialist with the department. One of first highlights of my tour was conservation. We surveyed a project near the Boise River and Barber Park that helps sustain natural wildlife. After a record-breaking floating season and more usage of Ada County facilities than ever before, there was much maintenance work to do. As Sosin explained, a small section of Barber Park was being improved with the help of volunteer groups who are putting in new native plant life to ensure a biodiverse and localized ecosystem. From there, we visited the on-site workshop where we met Waterways Maintenance Supervisor Jarrod Mathews. Mathews was delighted to show me all the heavy equipment being used by the department and how it is maintained internally. This was truly novel to examine how the land and its long-term management is undertaken by a hardworking group of Ada County officials who all genuinely care for their occupation and their community. The second half of the tour involved examining the other properties that Ada County has under its jurisdiction for the purpose of recreation. We visited the Ada County Hubbard Reservoir **Recreation Area and Oregon Trail Recreation Areas** and Ada/Eagle Bike Park where we met Davev

Brown, the Trail Crew Foreman. His job is to ensure that all the miles of trails and walkable areas in the County's control have easy accessibility and as little erosion as possible. This ensures that everyone from horseback riders to mountain bikers, have an excellent experience on our trails and recreation land.

Overall, the important work done by Ada County Parks & Waterways promotes better conservation and recreation on county land! Next time you're on the river or on the trail wave to our fine folks wearing the county emblem upkeeping these timeless treasures!



### ADA COUNTY IS UPDATING OUR ANIMAL CONTROL ORDINANCE



Share with us your thoughts! BOCC1@adacounty.id.gov Ada County is updating its Animal Control Ordinance. An updated version of the Animal Control Ordinance will be discussed further during the December 27, 2022 Open Business Meeting (OBM) at 9:00 AM.

Commissioners heard initial comments during the Nov. 29th OBM and tabled their decision to the Dec. 27th meeting. Review the <u>DRAFT update</u> / <u>DRAFT update Red Lined Version</u> and share with us your thoughts at <u>BOCC1@adacounty.id.gov</u>

Remember: If you live in the City of Boise, Eagle, Star, Kuna, Garden City or Meridian please review your city's respective ordinance which would apply to you and your family. The ordinance under review right now applies to Unincorporated Ada County – areas of Ada County that are not within city limits.

The Ada County Animal Control Ordinance is enacted to provide for the health, safety and welfare of the people of Ada County and the humane and safe treatment of various animals. The ordinance also establishes required procedures and regulations for the licensing and control of dogs and kennels.
