Early Voting Begins Monday, May 6

(Boise, ID) – Early voting will be available in Ada County for the May 21, 2024, Primary Election, beginning Monday, May 6. Early voting is available at Ada County Elections, Meridian City Hall, Boise City Hall and the Eagle Public Library, weekdays, May 6 - 17 from 8 a.m. to 5 p.m.

Eligible voters may vote at any of the early voting locations. Anyone who is not registered to vote may register and vote at any of these locations by bringing proper photo ID and proof of residence.

Ada County Elections will also utilize its Mobile Voting Unit during early voting. The trailer will travel across the Treasure Valley visiting public library locations and be open for the public from 10 a.m. to 5p.m.
