## **Internal Review Reveals Minor Results Update**

(Boise, ID) – From election night to the certification of official results, our team of dedicated election staff are ensuring that every single ballot cast in Ada County is accounted for, and the data is available for the public to view.

A routine post-election night internal review identified a single batch of 33 ballots (24 republican and 9 democrat), that were properly scanned on election night but due to human error were not uploaded to the results page.

The updates to the unofficial results did not impact the outcome of any of the contests. The unofficial results have been updated on our website to show the correct vote totals. The affected contests can be viewed below.

"Our emphasis on multiple layers of checks and balances worked to ensure the voices of Ada County voters are accurately reflected in our results," Ada County Clerk Trent Tripple said. "Election results will be officially certified on May 28th."
