ADMINISTRATIVE ORDER
NO. 21-09-01

Administrative Order No. 21-08-27 allowed jury trials to continue in Boise County and for jury trials to resume in Ada County on September 7, 2021. That order also specified that the court would continue to assess the COVID-19 situation and could preclude jury trials by further order, if circumstances warranted. Jury trials were already suspended for that time period in Elmore County and Valley County.

As of yesterday, Ada County's COVID-19 seven-day moving average incidence rate remains below the Idaho Supreme Court's threshold for holding jury trials, as does Boise County's. However, Ada County's COVID-19 hospitalization and ICU admission rates are both very high and the number of ICU beds available in Ada County is very low.

Ada County hospitals receive patients from counties other than Ada County and the most recent COVID-19 seven-day moving average incidence rate numbers from neighboring counties such as Canyon (53.2/100,000), Elmore (41/100,000), Gem (40.2/100,000), and Valley (26.3/100,000) remain high, and they are still relatively high in Ada County (18.9/100,000) and Boise County (18.2/100,000).

The hospital and ICU bed availability situation state-wide is such that crisis measures may soon have to be implemented.³

Exercising the discretion permitted to the Administrative District Judge in these circumstances,⁴ Administrative Order No. 21-08-27 is rescinded as to the resumption of jury trials in Ada County and the continuation of jury trials in Boise County for the calendar week commencing September 7, 2021. This means that there will be no jury trials in the Fourth Judicial District for the calendar week of September 7, 2021.⁵

As provided in the Supreme Court's Order, "the time used to calculate the right to a speedy trial pursuant to I.C. § 19-3501 shall be deemed to have been tolled for those counties affected by said order." Idaho Supreme Court's June 25, 2021 Amended Order Re: Emergency Order Regarding Court Services, at 4.
