

Program Participation

Diversion is a voluntary program in which the Prosecuting Attorney may refer a youth for low to mid-level offenses as an alternative to formally processing the youth through juvenile court.



Repeat Diversion

- > 2,295 unique youth participated in Ada County's diversion program
- \geq 23 (1%) of these youth were recommended for the program a second time - only 1 recidivated after the second term

2/3s of the 56 youth who did not participate in diversion have since been petitioned and/or placed on probation

1/3 had no additional court involvement for their charges because the prosecutor declined to file a petition or the court dismissed the case



Terms are collaboratively developed with the youth and family and may include reparation, victim-offender mediation, letters of apology, competency development/skill building assignments, therapeutic programs, and/or additional assessments and classes.

While most youth require 100 days or more to complete their program, a small group are "counseled and released" with no additional requirements.





Program Success


Success = youth completes all terms, pays all fees and fines, and does not re-offend during the program








We use Idaho's statewide definition of recidivism for youth who successfully complete Ada County's diversion program, which defines recidivism as being adjudicated or convicted on a new felony or misdemeanor.

To evaluate additional involvement in the criminal justice system, we count any new or pending adjudication or conviction after the date of successful diversion closure. Juvenile adjudications were identified by a new probation/IA term in IJOS and for youth older than 18, adult convictions by a new case in iCourts not including infractions or misdemeanor traffic offenses. Date of the associated offense (not the filing, adjudication or conviction date) is used to calculate time to re-offend.
